PIAP Purpose:

The plan described below will serve as the PIAP for the project. The plan is based on the information known about the project at the time this document is drafted/updated. Its purpose is:

- To communicate project information to the community (local officials, stakeholders, and the public) and solicit project feedback.
- To facilitate advancement of project Purpose, Needs, Goals and Objectives developed by The Project Team in consultation with the community (local officials, stakeholders, and the public).
- To facilitate an efficient and effective public involvement process by advancing the project to conclusion.

The PIAP is a "work in progress" document that will be amended in consultation with the Project Team, as the project advances. Public involvement in the scoping process is intended to achieve:

- A partnership review of conceptual alternatives.
- Selection of the best alternative that meets the Purpose and Need as developed in project scoping for advancement to design.
- Municipal Resolutions of Support for the recommended Preferred Alternative.
- Federal Highway Administration approval of the NEPA document (Environmental Assessment (EA)).
- Comply with federal and state regulations regarding public outreach, including but not limited to (Section 106, Section 4(f), NJ Register Act and NEPA).

The plan includes a number of strategies intended to provide opportunities for the local officials, stakeholders and communities, particularly those to be impacted by the project, to maintain effective dialogue with the Project Team.

Project Description:

Monmouth County is proposing to improve (rehabilitate/replace) three bridge structures located at the border between the Boroughs of Brielle and Manasquan. The project area has been collectively known as "Three Bridges" to the residents of Brielle and Manasquan Boroughs since the late 1800s and it encompasses the following three water crossings linking the two boroughs:

- Green Avenue over Debbie's Creek (Bridge W-7)
- Fisk Avenue Culvert (Structure W-8)
- Brielle Road over The Glimmer Glass (Bridge W-9)

The three roadways form a "T" intersection, with Fisk Avenue and Brielle Road comprising the flange of the "T" (east/west direction) and Green Avenue being the stem (north/south direction).

All three structures require improvement. The bridge approaches and connecting roadways also need improvement as the three structures help link the Boroughs of Manasquan and Brielle and serve as a primary access for commercial, recreational, and emergency response vehicles, as well as bicycles and pedestrians.

Project Purpose:

The purpose of the project is to provide safe and efficient crossings for all modes of travel within the project limit by addressing the geometric, structural, and operations and maintenance deficiencies of Bridge W-7 (Green Avenue over Debbie's Creek), Structure W-8 (Fisk Avenue Culvert) and Bridge W-9 (Brielle Road over The Glimmer Glass).

Property owners with rental units will be advised that tenants are invited and encouraged to participate in the process.

A presentation will be made followed by an open house format where attendees will have an opportunity to review project exhibits, ask questions, and discuss issues with Project Team members. They will be encouraged to actively participate by providing comments at the meeting, by mail, or by e-mail.

<u>Mailing List:</u> The mailing list will include local residents, technical and elected officials, public interest groups, etc. The Project Team provided guidance on the extent of the geographic range of property owners and other stakeholders included on the mailing list. The geographic range typically includes property owners 250 feet from the project limits; however, since this project involves access via three bridges, we have expanded the area beyond that area. The PIAP also includes notices of the public meetings on local government websites as well as newspaper notices and requests for permission for notices to be physically posted at various sites as discussed in the Media section below.

<u>Date:</u> The PIAP uses several strategies to reach stakeholders. The date of PICs will be selected in an effort to be convenient to stakeholders.

<u>Time</u>: It is anticipated the PICs (one at each municipality) will be scheduled the same day with (approximate times) an afternoon session from 2-4 PM and evening session from 6-8 PM on a weekday. The time of the PICs will be noted and attendees will be asked to come at a time and location convenient for them.

• Title VI - Environmental Justice (EJ)

Title VI of the 1964 Civil Rights Act prohibits discrimination on the basis of race, color or national origin in programs and activities supported by Federal funding. It specifically states: "no person in the United States shall, on the ground of race, color or national origin, be excluded from participation in, be denied benefits of, or be subjected to discrimination under any programs or activity receiving Federal financial assistance."

Executive Order 12898 extends the protection of Title VI to low-income populations. With respect to the PIAP, the intent is to not to discriminate on the basis of race, color, national origin or low income and assess if any special accommodations should be taken.

The above data generally shows that the project is not likely to disproportionately impact low-income, minority, or LEP populations.

As a result, it seems no special services, such as bilingual interpreter at meetings, meeting information published in another language will be needed for the PIAP. Furthermore, Monmouth County, Borough of Brielle nor Borough of Manasquan provide interpreters at other public meetings, thus will not be provided at these meetings, unless deemed necessary in the future should circumstances change.

The PIAP will address provisions of Section 4(f) of the US Department of Transportation Act of 1966 which established the requirement for consideration of park and recreational lands, wildlife and waterfowl refuges, and historic sites in transportation project development. The law, now codified in 49 U.S.C. §303 and 23 U.S.C. §138, is implemented by the Federal Highway Administration (FHWA) through the regulation 23 CFR 774.
